Participant Release of Liability

In consideration for being allowed to participate in any way at YP of Naples, Inc.'s Dodgeball Tournament (hereinafter the "program" or "event"), being sponsored by the YP of Naples, Inc.'s DBA Young Professionals of Naples and the Boys and Girls Club of Collier County (hereinafter "RELEASEES"), we the undersigned hereby acknowledge, appreciate, and agree that:

1. Dodgeball is a dangerous, contact sport. The risk of injury is significant, including the potential for permanent disability and death, and while particular rules, equipment and personal discipline may reduce risk, the risk of serious injury to me does exist; and,
2. **I KNOWINGLY AND FREELY ASSUME ALL SUCH RISKS**, both known and unknown, **EVEN IF ARISING FROM THE NEGLIGENCE OF THE RELEASEES** (as set forth in paragraph 4 below) or others, and assume full responsibility for my participation; and,
3. I willingly agree to comply with the stated and customary rules, terms, and condition for participation. If I observe any unusual significant concern in my readiness for participation and/or in the sporting event itself, I will remove myself from participation and bring such to the attention of the nearest official immediately; and
4. I acknowledge that drugs and/or alcohol, in any form, are prohibited at this event; and
5. **I FOR MYSELF AND ON BEHALF OF MY HEIRS, ASSIGNS, PERSONAL REPRESENTATIVES AND NEXT OF KIN, HEREBY RELEASE, INDEMNIFY AND HOLD HARMLESS, THE RELEASEES, ITS AGENTS, EMPLOYEES, OTHER PARTICIPANTS, SPONSORING AGENCIES, SPONSORS, ADVERTISERS, AND IF APPLICABLE, MEMBERS OF THE RELEASEE FROM ANY AND ALL CLAIMS ARISING OUT OF MY PRESENCE AT THE EVENT, INCLUDING BUT NOT LIMITED TO, CLAIMS FOR ANY AND ALL INJURIES, DISABILITY, DEATH, OR LOSS OR DAMAGE TO PERSONAL OR PROPERTY, WHETHER ARISING FROM THE NEGLIGENCE OF THE RELEASEE OR OTHERWISE, TO THE FULLEST EXTENT PERMITTED BY LAW, INCLUDING ATTORNEY'S FEES AND ATTORNEY'S FEES ON APPEAL.**
